

Easy Entertaining Inc. Referral Program Terms and Conditions

Welcome to Easy Entertaining's Referral Program (the "**Program**"). The Program allows Easy Entertaining's current clients to earn a discount off of future services for every new client they refer to Easy Entertaining's catering services.

By participating in the Program, you agree to the following Terms and Conditions (the "**Terms**"). If you do not agree to the Terms then we ask that you refrain from participating in the Program.

Definitions

"Referrer" - current client of Easy Entertaining

"Referee" - client sent to Easy Entertaining by the Referrer. Must list Referrer's name on their inquiry form or give Referrer's name to an Easy Entertaining sales agent.

"New Client" - someone who has not used Easy Entertaining's catering services in the past

"Catering Service" - food and/or labor services with Easy Entertaining ranging from, but not limited to, pick up/drop off catering, weddings, fully service social events, Drop and Style offerings.

"Qualified Referral" - occurs when a referee completes final payment on a catering service with Easy Entertaining Inc.

Eligibility

An eligible Referrer must be a client with Easy Entertaining who has completed one type of catering service. Employees of Easy Entertaining are not eligible to enter this promotion.

Program Participation

Referrers of Easy Entertaining have an opportunity to earn a discount voucher for successfully referring New Clients to Easy Entertaining's catering services. Vouchers will be sent to the Referrer once the Referee has completed the final payment on their transaction.

Rewards & Restrictions

For each Qualified Referral attributed to you, you will earn a discount voucher for 10% towards the food and beverage cost of a future catering purchase.

You may earn multiple vouchers if multiple Qualified Referrals are attributed to you. Vouchers may not be redeemed for cash or combined with any other offer. You may only use one voucher per catering transaction. Vouchers will expire one year from the date of receipt. Voucher will not count towards bar services, labor charges, rental charges or venue rental charges.

Use of Materials

We may, at our discretion, provide you with marketing and promotional materials pertaining to Easy Entertaining and its services. We grant you, during the terms of this agreement, a limited right to copy the provided materials for the sole purpose of promoting and marketing Easy Entertaining to potential New Clients.

All goodwill and other benefits created through your use of the above mentioned materials shall insure solely to the benefit of Easy Entertaining. Nothing herein shall grant you any ownership or title in these materials, but only limited rights of use as described above.

Term

The term of these Terms will begin upon your acceptance of these Terms and will end when terminated. Easy Entertaining may terminate this Agreement at any time, with or without cause, by giving you five (5) days prior written notice of termination.

Easy Entertaining has the right, on its sole discretion, to cancel this program at any time.
